

### **Commitment Billing Terms and Conditions**

1. These Commitment Billing Terms and Conditions (“**T&C’s**”) are to be read with the Terms and Conditions of the Invitation Campaign (mentioned in **Schedule – 1** below), valid for the Campaign Period (to the extent not contradictory to these T&C’s). By availing the Option (as defined hereinafter). I give my unequivocal, unconditional, and absolute consent to these T&C’s along with the Invitation Campaign Terms and Conditions (“**Terms**”).
2. I understand and acknowledge that, as a 22% level Brand Partner, Oriflame is providing campaign Accessory (as defined hereinafter) to me at a discounted price of INR 399 prior to the completion of Invitation Campaign starting from 1st August ,2023 until 31st August,2023 (“**Campaign Period**”) against a commitment that I will fulfil the qualification criteria of introducing **4** (four) new Brand Partners and each such **4** Brand Partner shall make a **55BP** order during the relevant Campaign Period (“**Option**”). The said Option shall be available to the eligible brand partners for 10 days i.e. between 11th August ,2023 to 18th August,2023.
3. I agree to the following specific terms and conditions in respect of the Campaign Benefit being provided to me:
  - a) The Products from Campaign- Code 147651 Philips Hair Styling Kit
  - b) Availing of this Option is voluntary and every eligible Brand Partner who desires to avail this Option may do so pursuant to independent inquiry, investigation and analysis and shall not have any claim against Oriflame or its directors, employees, associate companies and/or vendors whatsoever by reason of any loss which may be suffered by such person consequent to or in connection with this Option whether by reason of anything stated or omitted to be stated herein.
  - c) Upon availing the Option, I agree to complete/achieve the following criteria specified in clause 2 above within the Campaign Period.
  - d) If I fail to fulfil the aforesaid qualification criteria during the Campaign Period, I agree to pay Rs.2495 to Oriflame being the MRP of the said Accessory. In such a case, the aforesaid amount of Rs 399 shall be adjusted by Oriflame towards the payment of MRP. Without prejudice to any other legal or contractual rights of Oriflame, I further expressly agree and acknowledge, that Oriflame also retains the right to deduct the difference amount of Rs. 2,096 from any amount payable to me.
  - e) I agree to remit all applicable taxes, levies, duties, cesses and surcharges, and Goods & Services Tax (“GST”) on the supply of such Accessory to me as per the T&C’s set forth herein.
  - f) If the price payable or to be provided for the aforesaid supply or transaction is increased, I agree to pay to Oriflame, an amount equal to the GST payable by it to the tax authorities on that supply.
  - g) I agree that Oriflame may deduct applicable taxes (TDS) as per the provisions of Income Tax Act wherever applicable.
  - h) I acknowledge and understand that I have read and understood the Terms (including the Brand Partner Terms forming part thereof) before availing the Option.
